Classification Series/Occupational Group: Legal Classification Title: District Attorney DBM Range: C44-C4PremA # of Subgrades: 3 FLSA: Exempt		<b>Series Summary:</b> Incumbents in the Legal Professional series are licensed attorneys providing professional legal services to the County in the areas of prosecution and litigation. This classification encompasses incumbents responsible for upholding state and federal law in the prosecution of criminal, juvenile delinquency, dependency, forfeiture, child support, and civil commitment proceedings, which includes the preparation and litigation of cases including murder and aggravated murder. Specific duties could include; reviewing police reports and criminal investigations to develop cases; negotiating with defense attorneys and preparing plea offers; conducting litigations and providing advocacy; and drafting recommended policies and procedures for law enforcement staff. Exact assignments and responsibilities will vary in accordance with the following competency levels:
