Treat diseases of the gums. • Provide preventive services through use of fluorides, Silver Diamine Fluoride and sealants; instruct patient and family members on dental care. • Administer local anesthetics, nitrous oxide when necessary for carrying out treatment. • Accurately code and document in the health record according to protocol; complete documentation within the established time frame; review reports to proactively manage care. 	80%
